Applicants must be enrolled as a high school senior, and/or plan to continue or pursue a post high school program in a college, university or school providing trade, business or technical programs.

First-time applicants must have achieved at least a 3.0 grade point average, or the equivalent in their previous educational program.

A renewal Scholarship is not guaranteed. You must re-apply each year, and include your most recent transcripts and letters of recommendation.
